1 I, Bradley Madden, hereby declare as follows:

I am a Project Manager for Postlethwaite & Netterville, APAC ("P&N"), a full-service
 administration firm providing legal administration services. The following statements are based on my
 personal knowledge as well as information provided by other experienced P&N employees working under
 my supervision.

Con January 10, 2022, the Court approved the Notice Plan and appointed P&N as the Class
Administrator in the *Order Granting Preliminary Approval of the Settlement* (the "Order," Dkt 248). The
Court conditionally certified a Class defined as "all Persons in the United States who purchased one or more
canisters of ADEG that were manufactured as part of the Recalled Lots, except for Excluded Persons."

Upon preliminary approval of the Settlement, P&N began to implement the Notice Plan as
 described in the January 10, 2022, *Declaration of Bradley Madden Regarding Proposed Administration* ("Madden Declaration," Dkt. 247-4). This declaration will discuss the implementation of the Notice Plan
 and settlement administration.

NOTICE PLAN EXECUTION

NOTICE DATABASE

4. P&N maintains a database of 213,044 Class Member records which was used to effectuate
the notice campaign as outlined within the Settlement Agreement. P&N received the two different class data
files on November 15, 2021: (1) The list of customers that Defendants have identified as purchasing
product(s) from the Recalled Lots, and (2) the list of customers who have been identified as receiving a
refund. The first list consisted of names, addresses, email addresses, and Customer IDs, while the second
list consisted of names and Customer IDs. P&N determined that there were 213,044 unique Class Members
that did not already receive a refund from Defendants.

MAIL NOTICE

5. On February 9, 2022, P&N coordinated and caused the mailing of the Postcard Notice to be mailed via Business Reply Mail to all 213,044 Class Members at the mailing addresses provided by Defendants. The Postcard Notice included the URL to the case website for access to additional information, the URL to access the Claim Form and the return address of the P.O. Box maintained for the purpose of receiving the Claim Form submissions and undeliverable Postcard Notices in connection with this

MAIL NOTICE DELIVERY

3 6. Prior to the mailing, all mailing addresses were checked against the National Change of Address (NCOA) database maintained by the United States Postal Service ("USPS"). In addition, the 4 5 addresses were certified via the Coding Accuracy Support System (CASS) to ensure the quality of the zip code and verified through Delivery Point Validation (DPV) to verify the accuracy of the addresses.

SECOND MAILED NOTICE

8 7. After 30 days, P&N coordinated a reverse lookup analysis to obtain mailing addresses associated with 28,275 Postcard Notices deemed to be undeliverable (13.27%). This process resulted in mailing addresses for 26,161 (92.52%) records representing 12.0% of all Class Members. Of these, 497 addresses were undeliverable as determined by NCOA.

12 8. On March 24, 2022, Postcard Notices were mailed to 25,664 Class Members who had not 13 received Mailed Notice in the initial distribution due to a returned or dropped Postcard Notice.

NOTICE PROGRAM REACH

9. The Direct Notice program conducted by P&N reached a total of 203,785 (95.7%) Settlement Class Members. Table 1 below provides an overview of dissemination results for the Notice Program.

EMAIL REMINDER

10. In the initial data sets received, P&N identified 87,119 class members with a known email address. P&N sent an email reminder on April 7, 2022, to 73,461 email addresses, after removing those who had already submitted a claim as well as any email flagged by email validation. A true and correct copy of the email reminder is attached hereto as **Exhibit B**. Table 2 below provides an overview of dissemination results for the email reminder.

SETTLEMENT WEBSITE

11. On February 8, 2022, P&N established Settlement Website, the 19 www.NaturMedIVLSettlement.com. Visitors to the Settlement Website can download the Long Form 20 Notice, the Claim Form, as well as Court Documents, such as the Class Action Complaint; Settlement 21 Agreement; Motions filed by Class Counsel; and Orders of the Court. Visitors are also able to submit claims 22 electronically, submit address updates electronically, and find answers to frequently asked questions 23 (FAQs), important dates and deadlines, and contact information for the Claims Administrator. As of May 24 9, 2022, the Settlement Website has received 27,428 unique visitors and 89,401 page views. 25

P&N established the email address, *info@NaturMedIVLSettlement.com*, to provide email

SETTLEMENT POST OFFICE BOX

13. P&N also established a dedicated Post Office Box ("P.O. Box"): NaturMed/IVL Settlement Administrator P.O. Box 3958 Baton Rouge, LA 70821

14. The P.O. Box serves as a location for Class Members to submit Claim Forms, exclusion request forms, and other Settlement related correspondences. The P.O. Box appears in the Long Form Notice and in multiple locations on the Settlement Website. P&N monitors the P.O. Box daily and uses a dedicated mail intake team to process each item received.

DEDICATED TOLL-FREE HOTLINE

15. On February 8, 2022, P&N also established the toll-free hotline, 1-844-563-0649, dedicated to this Settlement. The toll-free hotline is accessible 24 hours per day, seven days per week and utilizes an interactive voice response ("IVR") system where Class Members can obtain essential information regarding the Settlement and be provided responses to frequently asked questions. Class Members have the option to leave a voicemail and receive a call back from the call center representative. The toll-free hotline appears in the Short Form and Long Form Notice and in multiple locations on the Settlement Website. As of May 9, 2022, the toll-free hotline has received 1,313 calls and 256 voicemails, totaling 3,455 minutes.

CLAIM FORM SUBMISSIONS

16. P&N has received 10,373 claims as of May 9, 2022. The deadline for claim submissions is May 20, 2022. Upon request, P&N will provide a declaration with updated claim submission statistics.

17. Table 3 below provides summary statistics of claim submissions. P&N shall continue to analyze claims that have already been received as well as any additional timely claims mailed to the P.O. Box and postmarked by the claim filing deadline.

18. As the claims deadline has not passed, P&N can only provide approximate counts and

tabulations for the number of vouchers as well as the number and amount of the pro-rata share for alternate
payments. To date, P&N has received 4,237 claims for Settlement Credits and 6,136 claims for Alternative
Payments. As indicated on the Postcard Notice claim form, all claims with no selection of Settlement Benefit
will receive a Settlement Credit. P&N continues to review the claim forms and counts are subject to final
review and validation. Based on the current total of claims received and reviewed, the Alternative Payment
would be approximately \$16.29, though this amount will likely decrease as additional claims are received
and processed through the claims deadline.

8 19. After the claims deadline has passed, P&N will identify and remove duplicate claims or
9 otherwise invalid claims.

20. Duplicate claims are defined as two or more claims submitted with either the same name and
address, or the same name and Settlement Claim ID. In instances where duplicate claims are identified,
P&N will count only the most recently submitted claim.

13 21. Invalid claims consist of claims that were not identified in Defendants' data provided for the
14 Notice Program and did not contain appropriate documentation to validate status as a Class Member. P&N
15 will send a notice to each invalid claim, providing an opportunity for the claimant to submit appropriate
16 identification in order to validate their claim.

EXCLUSIONS AND OJECTIONS

18 22. The deadline for Class Members to ask to be excluded from the Settlement was April 11,
19 2022. To date, P&N has received one (1) exclusion, which has been provided to the Parties. The Class
20 Member requesting to be excluded and accompanying exclusion request are attached as Exhibit C.

21 23. The Order directs Class Members to either file objections with the Court or mail them to the
22 Claims Administrator. P&N has not directly received any objections.

NOTICE AND ADMINISTRATION EXPENSES

24 24. P&N has incurred \$123,731 in fees and costs, including postage, completing the Notice Plan.
25 P&N has also incurred \$75,422 in fees and costs administering the Settlement. P&N anticipates incurring
26 \$47,911 in additional fees and costs for administration, for a total administration cost of approximately
27 \$247,064.
